Youth Development Squad Selection Guidelines

Central Region Champs - Sunday 9 December 2018

Taupo BMX Club and Facility

Taharepa Road, Taupo

Male – 4 riders

Female – 4 riders

This event will be to select a squad to coach & develop with the aim to travel to Australia in early 2018 to compete in the AUS National Series

The selection is open to riders who will be the set UCI age at time of trial.

Male - the top two 13yr & top two 14yr riders

Female - the top four 13yr or 14yr riders

RACE FORMAT - Youth Development Squad:

Gender Split: Separate Male & Female trial will be held

Youth Male: 8 or less riders - 6 motos, points over.

9+ riders - 4 motos, each rider's 3 best moto points will be added.

Top 4 scoring riders aged UCI 14 and UCI 13 will race a 3 heat final, with the top 2 of each age group being selected for the Squad.

Youth Female: 8 or less riders - 6 motos, points over.

9+ riders - 4 motos, each rider's 3 best moto points will be added.

Top 8 scoring riders of either age UCI 13 or UCI 14 will race a 3 heat final, with the top 4 overall, being selected for the Squad.

BMX NZ moto mix for all qualifying motos. Points from the motos will not be carried over into the final heats. Lane selection for finals will utilise the BMX NZ Superclass Series lane rotation.

ENTRY FEE: \$35.00

ENTRIES CLOSE: Sunday 2 December 2018 - **NO LATE ENTRIES ACCEPTED**

REGISTRATION: Sunday 9 December 9.00 – 10.00 am.

TERMS & CONDITIONS OF ENTRY:

1. All riders must also compete in the 2018 Central Region Champs meeting in any age group class.

2. Selected Riders and Guardians will be required to sign and comply with the BMX NZ Devo Squad Contract. Contracts are to be signed on the day of selection. Copies of the Devo Squad Contract are available upon request from BMXNZ at admin@bmxnz.co.nz

3. Riders must be available to attend all Squad training sessions as arranged by BMXNZ Devo Squad Management.

4. Information contained within this flyer supersedes all other information or flyers previously provided

5. All riders must abide by the rules and regulations as set by BMX NZ and the 2017 Devo Squad management

6. Any rider wanting to be eligible for selection for a BMX New Zealand Team must be permanently resident, in New Zealand for the all of the relevant BMX New Zealand racing season (as published in the annual racing calendar) and up to the date or dates of the events for which the rider wishes to be considered for selection. "Permanently Resident" means actually living in New Zealand, and intending to live here indefinitely.

SELECTED YOUTH DEVO SQUAD RIDERS:

All selected riders must provide a copy of a current passport and entry visa to Australia (if required) to the Devo Squad Manager by 30 December 2018.

Riders must be available in 2019 to travel to Australia. It will be the rider's responsibility to get to and from Auckland Airport. All Devo Squad members will fly on the same flight to and from Australia from Auckland Airport.

Riders must provide a copy of their travel insurance to the Devo Squad Manager prior to 30 December 2018, covering the rider for accidents involving BMX racing.

Riders selected for the Devo Squad will be required to pay to BMX NZ **\$500.00** to assist with covering costs of the Australian part of the program.

BMXNZ EVENT HEALTH & SAFETY STATEMENT

BMXNZ, The Central Region & Taupo BMX Club will comply with the requirements of the Health and Safety in Employment Act 2015 by committing to providing and maintaining a safe and healthy environment for all riders, families and visitors to the BMX Event facility. BMX Racing is an action sport & inherently has risks that are accepted as part of sport. All known risks are noted in the Meeting RMP & this is available onsite during the event. Parties wanting to assess the RMP prior to entry must contact the club for detail. Entry to this event confirms an understanding of the risks of the sport as noted in the RMP. In the event of injury to an event participant, a completed entry is consent to proper medical treatment being administered. Event entry also consents to submit to drug testing if required. All entrants agree to be bound by the regulations and general conditions for this event as published by BMXNZ in its latest rule book. Any reference to BMXNZ within this flyer or entry is referring to BMX New Zealand Inc.

Safety and safe practices at all BMXNZ calendared events are not negotiable and failure by anyone to comply by the code of conduct or rules of the sport will result in the removal of such person from the event facility.
